



## Lake of the Woods Golf Course - Anniversary 7- Day Membership

- ✓ The Anniversary Membership is a pre-paid green fee program for 2 years and applies to “open play” periods at Lake of the Woods Golf Course. This Membership is effective Monday-Sunday, 8:00 a.m. or later including holidays.
- ✓ This Membership is not valid for Scrambles, Club Outings, Leagues, Member Events, Club Tournaments, or Association Events.
- ✓ Cart fees are not included in membership, per player prices are below. Add \$5 if single rider cart is requested.
  - 18 holes before 1pm - \$16      18 holes after 1 pm - \$10      9 Holes - \$10
- ✓ Anniversary 7-Day Members are only allowed to make and/or play on tee-time reservations made seven (7) days in advance or less. Tee times are required and may be made online or over the phone.
- ✓ All players should expect to be paired up to make a foursome when possible. Also, groups showing with less than their reservation are subject to our no show policy.
- ✓ Members, Guests and Public Players alike must check-in with the golf shop staff before going to the tee box by showing their driver’s license or valid ID. If anyone uses your membership card other than yourself, your membership will be terminated immediately with no refund.
- ✓ For the benefit of everyone, all play starts on #1 unless otherwise specified.
- ✓ Our Members agree to set an example by using proper etiquette and playing within our pace of play guidelines. See pace guidelines on scorecard.
- ✓ Lake of the Woods Golf Course will be solely responsible for distribution of all food and alcoholic beverages at the facility. No outside coolers or drinks are allowed.
- ✓ This Anniversary Membership is valid thru December 31<sup>st</sup>, 2022. No refunds will be given after May 30<sup>th</sup>, 2021 for any reason.
- ✓ As a Season Pass Holder at the Lake of the Woods Golf Course, I recognize and acknowledge there are certain risks of physical injury, and I agree to assume full risk of injuries, including death, damages or loss that, I may sustain as a result of participating in any activity connected with or associated with the Champaign County Forest Preserve District/Lake of the Woods Golf Course.
